House Bill 2179	Markosek		House Bill 2179 makes appropriations from the Workmen's Compensation Administration Fund to the Department of Labor and Industry and the Department of Community and Economic Development to provide for the expenses of administering the Workers' Compensation Act, The Pennsylvania Occupational Disease Act and the Office of Small Business Advocate for the fiscal year July 1, 2016, to June 30, 2017.
9. House Bill 2180	Markosek		House Bill 2180 makes appropriations from the Philadelphia Taxicab and Limousine Regulatory Fund and the Philadelphia Taxicab Medallion Fund to the Philadelphia Parking Authority for fiscal year July 1, 2016, to June 30, 2017.

House Bill 2183	Markosek		House Bill 2183 makes appropriations from the Professional Licensure Augmentation Account and from restricted revenue accounts within the General Fund to the Department of State for use by the Bureau of Professional and Occupational Affairs for the fiscal year July 1, 2016, to June 30, 2017.
